Carl Arnold's regular hourly rate is \$250/hr (\$125/hr per party) which is due at the end of the mediation. If either party would like to discuss our sliding fee scale for mediation based on having lower income, that phone call is the best time to do that and then we can send out an Agreement to Mediate by email using Digisigner.
